ALCOHOLIC BEVERAGE BOARD 1-year term 1 position IC 7.1-2-4

- Must be at least 21 years of age.
- Must be a bona fide resident of the county for at least 6 years.
- Must not have a conviction within 10 years of a federal crime having a sentence of at least 1 year; an Indiana Class A, Class B, or Class C felony (for a crime committed before July 14, 2014) or a Level 1, Level 2, Level 3, Level 4, or Level 5 felony (for a crime committed after June 30, 2014). This does not apply to a conviction that has been expunged.

ANIMAL WELFARE, CONTROL & EDUCATION BOARD 4-year term 2 positions O-C-11-7

- 1 position must be a member of a Perry County Ag-Animal organization.
- 1 position must be a member of a Perry County Animal Welfare organization.

CONVENTION, RECREATION, & VISITOR PROMOTION COMMISSION 2-year term 3 positions IC 6-9-18

- This is a 11-member board.
- A majority of the members must be engaged in convention, visitor, or tourism business; or involved in or promoting conventions, visitors, or tourism.
- Members need not be a resident of the county if the member is an owner or an executive level employee of a convention, visitor, or tourism business that is located within the county. However, the member must be a resident of Indiana.
- Except as otherwise stated, each member must reside in the county.
- If available and willing to serve, at least 2 members must be engaged in the business of renting or furnishing rooms, lodging, or accommodations.
- Not more than 1 member may be affiliated with the same business entity.

HEALTH BOARD 4-year term 2 positions (physician, general public) IC 16-20-2

- This is a 7-member board, not more than 4 may be from the same political party.
- Letters of interest from both parties may be submitted for this appointment.
- At least 1 appointment must be a Republican.
- 1 appointment must be a physician, and the other may be from the general public or from one of the following public health categories listed below.
- The board membership must consist of the following:
 - 4 members must be knowledgeable in public health, at least 2 of whom are licensed physicians. The other 2 may be any of the following: registered nurse, registered pharmacist, dentist, hospital administrator, social worker, attorney with expertise in health matters, school superintendent, veterinarian, professional engineer, environmental scientist.
 - 2 members from the general public.
 - 1 member from either of the previously mentioned 2 categories.
- Must be a citizen of the United States.
- Must reside in the county.

HOSPITAL ASSOCIATION **4-year term** **1 position** **IC 16-22-6**

- Must reside in the county.

PLAN COMMISSION **vacant term ending 12/31/20** **1 position** **IC 36-7-4**

- 5 citizen members are appointed by county executive of whom no more than 3 may be of same political party. (This vacant position may be filled by a member of either party.)
- Must be a resident of unincorporated areas of the county, or a resident of the county who is also owner of real property located in whole or in part in an unincorporated area of the county.
- At least 3 of the 5 citizen members must be residents of unincorporated areas of the county.

PORT AUTHORITY **4-year term** **1 position** **IC 8-10-5 R-C-91-1 R-C-05-2**

- Must be a resident of the county for minimum of 3 years.

PUBLIC DEFENDER BOARD **3-year term** **1 position** **IC 33-40-7**

- Must be a resident of the county.
- Must have a demonstrated interest in high quality legal representation for indigent persons.

PUBLIC LIBRARY BOARD **4-year term** **1 position** **IC 36-12-2**

- Must reside in the library district served by the public library for at least 2 years.

REDEVELOPMENT AUTHORITY **3-year term** **3 positions** **IC 36-7-14.5**

- Must be a resident of the county.

REDEVELOPMENT COMMISSION **1-year term** **3 positions** **IC 36-7-14-3**

- Must be at least 18 years of age.
- Must be a resident of the county.

ZONING APPEALS **Vacant 4-year term ending 12/31/2021** **IC 36-7-4**

- Must be a resident and own property in the jurisdictional area of the board or a resident of the county who is also owner of property located in the jurisdictional area.
- A majority of the 5 member board must be residents of the jurisdictional area of the board.
- No member can hold an elected office or any other appointed office.
- This appointment cannot also be a member of the Plan Commission.

INDIANA 15 REGIONAL PLANNING COMMISSION **1-year term** **1 Commissioner (or appointee)**
2 At Large positions **IC 36-7-7**

- 2 At Large members are appointed to represent the rural area of the county.
- 1 At Large member may be another Commissioner
- 2/3 of membership as a whole must be elected officials.

TELL CITY PLAN COMMISSION **4-year term** **1 position** **IC 36-7-4**

- When a municipal plan commission exercises jurisdiction outside the incorporated area of the municipality, the executive of the county in which the unincorporated area is located shall appoint 2 members to the municipal plan commission.
- Members must be residents of unincorporated area or resident of the county and owner of real property located in whole or in part within the unincorporated area.
- Members cannot be of the same political party. (This appointment cannot be from the Democrat party.)
