

**PERRY COUNTY COUNCIL
MINUTES
OCTOBER 13, 2020**

The Perry County Council met on the above date at 5:00 p.m. as was duly advertised for the adoption of the 2021 budgets. Council members in attendance were: President David A Etienne, Danny Bolin, Charlie Baumeister, Earla Williams and Lynn Fulkerson. Luke Thomas and Steve Goodson were not in attendance. S. Rod Acchiardo, Council Attorney, and a media representative from the Perry County News were also present. Sheriff Alan Malone was also in attendance.

The meeting opened with the Pledge of Allegiance.

2021 BUDGET ADOPTION

County Auditor Pam Goffinet explained to the Council about the cuts and where the levy funds set now after their two-day budget session. She informed them that as of right now, County General fund was cut by \$342,148.00, Health fund was cut by \$29,397.00, the 2015 Reassessment fund was cut by \$35,100.00 and Cumulative Bridge fund was cut by -0-, total cuts being \$406,645.00. In the four levy funds we were over the maximum levy to begin with. After all that, we are still \$2,159.00 over the max levy which is where we want to be. President David Etienne then read the levy amounts and rates for each fund and that the Council needs to adopt for the 2021 rates.

Also, Auditor Goffinet informed the Council about how the new estimated LIT income tax amounts came in on Friday before the budget meetings. The amounts came in higher than anticipated. Our DLGF representative, Robert Norris, said the numbers are good to use. Pam said she worked the new figures in to help save on the cuts that originally had to be made to the levy funds and LIT-Public Safety fund.

He thanked the Council for increasing the deputy’s position at budget time and for giving the office an additional person. He told the Council that the volunteers are helping in the office with putting all case reports in the computer from 1970 to the present. They are redoing all the files to make it easier to find information especially for the State Police. Charlie made the motion to advertise for the position to refill, seconded by Lynn. Motion carried 5-0.

The next meeting of the Council will be on October 22, 2020 at 5:00 p.m. at the Armory Annex conference room due to early voting.

There being no further business, Charlie made a motion to adjourn the meeting. Danny seconded the motion. Motion carried 5-0, with adjournment at 5:15 p.m.
